The Supplemental Nutrition Assistance Program is a federal program designed to assist low income individuals in purchasing food through an electronic benefits card, similar to a debit card. Senior citizens, many of whom are on fixed incomes, are an underrepresented population of those potentially eligible to receive benefits.
